



Request for Quote for the Grinding of Brush Pile

Central Huron invites you to submit a quote for grinding of various sized brush at our municipally owned compost and brush drop off site.

All bidders must physically visit the site located at 40131 Hydro Line Road Clinton Ontario as dimension of the brush pile cannot accurately defined and will not be provided.

Included in the quote price shall be delivery and operation of all equipment necessary to grind and stack brush pile into a grinding of a minimal size as is reasonably possible which will be agreed upon by the successful bidder and the Road Manager at the time of grinding.

Bidders can reach out to Roads Manager Nolan with any question and/or to schedule a site visit to view the brush pile.

It is at the sole discretion of the Municipality of Central Huron and the Roads Manager as to which bidder will provide the best value to the municipality and your signature at the end of the quotation acknowledges this.

The municipality may, in its sole discretion, choose to reduce the amount of work to keep costs within the municipality's budget. For example, if the municipality's budget is \$60 and the bidder submits a price of \$100.00 to grind the entire pile the municipality may choose to grind only 60% ($\$60 \text{ budget} / \100 bid) of the brush pile. The municipality will not disclose the budget for grinding prior to the award of the contract. However, the amount of the grinding to be completed will be agreed upon in writing prior to the start of work.
